Nasdaq CSD SE (Societas Europaea) is a Central Securities Depository with business presence in Estonia, Latvia, Lithuania and Iceland. It provides a post-trade infrastructure and a wide range of securities services for participants in all four markets. Nasdaq CSD is a fundamental element in these financial markets, serving as the central registrar of shares and other securities issued by companies and governments. Market data for Estonian, Latvian and Lithuanian markets are now available directly from the new CSD core system.

Nasdaq CSD Baltic Market Data

Market Data reports from Nasdaq CSD platform is now available for Baltic CSD markets. The available data reports are generated straight of the core CSD system and are available in standard csv-format.

Data Product Features

Nasdaq CSD data is available in three different reports covering CSD- issuers data, instruments data and corporate events. The three different files are updated daily. The reports can be used for automation of reference data updates and registration of new instruments.

CSD Issuers data

Over 7,000 issuers registered at Nasdaq CSD SE – Estonia over 6,800 public and private limited companies, Lithuania c.500 public and private limited companies, and Latvia c.100 public and private limited companies.

- Statistics information on issued volumes

Corporate Actions data

- Over 3,000 corporate events are being announced and processed by Nasdaq CSD SE per year

Access Options

Daily CSD reports are available via File Delivery Service (FDS) in .csv format. FDS is a web-based https solution to manage access to files from several source systems for European market data.

Data is available in 8 daily files: issuer data (active, delta and complete); instrument data (active, delta and complete); corporate actions data (delta and complete).

Complete reports will reflect active and inactive issuers/instruments/corporate actions since September 18, 2017.
